Uniforms

Vice President Matt Miethe emphasized the following:

- ✓ If veterans have used equipment that they would like to donate, please contact Rich Hobson. We would like to get new umpires on the field for as little expense as possible.
- ✓ Don't be sloppy. When you show up to the field make sure your uniform is clean and matches your partners.
- ✓ We are still in discussion with WOA regarding the requirement that the WOA shirts be worn for all high school games, not just for the playoff, but during the regular season as well.
- ✓ Rich Hobson will be setting up a uniform ordering opportunity at a future meeting, most likely in February

Professionalism

Lead Evaluator Larry Randall noted the following:

- ✓ **Evaluations:** In 2025 33 umpires were evaluated. Evaluations are a great way to get feedback, regardless of how long you have been umpiring. In 2026, evaluations can still be requested, but we are also going to be doing most evaluations incognito, i.e., you won't know when you are being evaluated, so we encourage all to do your best at every game.
- ✓ **Post-Season Playoff Assignments:** We would like to know ASAP who would like to be considered for post-season playoff assignments. To be considered for these assignments umpires will need to meet the following criteria:
 - Umpire a minimum of 10 varsity level games
 - Be registered with WOA for post-season eligibility (confirming availability for playoff dates)
 - Attend required training meetings and batting cage sessions
 - Be formally evaluated
- ✓ **Training Manuals:** Manuals have been prepared for distribution to all umpires requesting them. These manuals will contain articles, tips, checklists, etc. They will be provided free of charge. Contact Larry at umplarry@yahoo.com if you would like a manual.
- ✓ **Professionalism Characteristics:**
 - Good physical condition
 - Rules knowledge
 - Humility/controlling emotions
 - Neutrality/absence of bias
 - Hustle and focus
 - Proper Mechanics (positioning, timing, vocal clear communications)
 - Open to feedback/commitment to improving

NFHS Rules Update

Dwaine Schettler listed the five new rule changes for 2026.

- ✓ Electronic equipment is not allowed, except for one-way device between dugout to the catcher.
- ✓ Clarification of DH wording in the rule book

- ✓ Clarification of Courtesy runners/Illegal Substitution, i.e., slow guy for the catcher then switched defensively.
- ✓ Player meeting restriction; one player to player meeting per ½ inning
- ✓ Double first base mandatory first base in 2027, possibly implemented in WA this year.

Certification

The WOA portal for registration and certification is now open for the 2026 season. Veteran umpires already in Arbiter will need to renew their background check authorization and begin the process of completing the requirements for certification. Training Meetings

The question came up that since we are having training meetings in two separate sessions, one for veterans and one for new(er) umpires, which sessions should umpires who have only one year's experience attend? While all the new umpires should attend the trainings specifically for them, other umpires can choose which session they want to attend based on the topics being presented. Agenda for each of the training sessions will be sent out via Arbiter in the week prior to each session.

Final Thoughts

Kevin Wellington encouraged all (except for the new umpires) to consider pursuing post-season playoff assignments. He emphasized that it is a great opportunity and experience.
